Karnataka State Law University proposes to conduct Examinations for fresher students and repeater students of various semesters **from 21.09.2020**.The following information is provided for the Notice of all the students and staff of all affiliated law colleges of Karnataka State Law University regarding the fees structure prescribed, last dates of filling Online examination applications, submitting them to University and date of commencement of Examinations. Further Students/Colleges are required to fill **fresh subjects in one application and all repeat subjects in one application separately as available in our official website [www.kslu.ac.in](http://www.kslu.ac.in)**, along with requisite fees payable. The instructions from 1 to 8 are to be carefully followed along with Mandatory instructions.

**The acceptance and registration of applications for the examination is Provisional. Admission to examination is subject to students fulfilling all eligibility criteria to write examination, including eligibility for admission approval and attendance.**

**Note:** \* indicates that, this particular fee is not applicable to candidates belongs to SC/ST with annual income of not more than Rs.2,50,000 /- for taking Examination as **Fresher's only.**

## **SPECIAL INSTRUCTIONS**

1. The acceptance and registration of applications for the examinations is Provisional. Admission to examination is subject to the students fulfilling all other criteria prescribed, including eligibility for admission and attendance. Therefore, after the last working day principals are advised to intimate fulfillment of attendance requirements of their students in the prescribed proforma compulsorily.
2. Principals are informed to ensure that the fees amount collected from the students is to be credited or transfer the amount from your college account to University **Account No: 33339906448 (Branch Code 13201 and IFSC Code No is SBIN0013201)** within 3 working days from the last date mentioned in the Notification. (Any particular last date prescribed for entire corresponding amount collected from the students) And the details of such students be e-mailed to [examkslu@gmail.com](mailto:examkslu@gmail.com) on the last day (within 3 working days) before 5.30 p.m.
3. Students are required to remit Examination Form Fees (Rs.110/-) and Marks Card Fees (Rs.185/-) in addition to applicable Examination Fees.
4. In accordance with Notification issued by Commissioner of Backward Welfare Department of Karnataka State (Notification No.397/2013 dated 05.09.2013), among all the candidates coming under SC, ST and only those coming under Category – I, 2(A), 2(B), 3(A), 3(B) **with annual income of not more than Rs.1,00,000/-** are exempted from paying Examination Fees for **Fresh Semester Only.**(**For any further information regarding fees exemption, you are informed to inquire with the concerned Government department and reimbursed the exempted fees**) But these candidates must remit Examination Form Fees (Rs.110/-) and Marks Card Fees (Rs.185/-). Further, Principals have to furnish this information to State Government within 10 days and follow up the issue with said department, in getting exempted fees reimbursed and such amount be remitted to KSLU, Hubblili within 3 days from reimbursement from State Government.
  - (i) All applications for above mentioned course/semesters for Fresher's and Repeaters forms are available **in our official website [www.kslu.ac.in](http://www.kslu.ac.in) and after filling on line application, you have take a print out of the application form and it should be signed by the student and certified by the Principal of the college.** Further all examination applications should be sent to the University along with the required documents, on or before last date mentioned in the Notification.( you are requested to send Fresher's and Repeaters applications in a Separate cover).
  - (ii) It is to be noted that remitting fee and submitting examination application is **mandatory** for students seeking promotion to next semester or next academic year 2020-21 if eligible otherwise.
5. All **Repeater** Students belonging to SC,ST ,Category –I, 2(A), 2(B), 3(A), 3(B) are informed to pay full fees as mentioned in the Notification, as per the Government Order( ಸರ್ಕಾರದ ಆದೇಶ ಸಂಖ್ಯೆ: ಸಕಇ 178 ಪಕವಿ 2015, ಬೆಂಗಳೂರು, ದಿನಾಂಕ: 31.12.2015).Hence all **Repeater students are required to pay full fees as per the Notification.**

6. Online filled Examination Application forms without penalty, with penalty of Rs.100/- and penalty of Rs.1,500/- should be sent to the University in time, as per the notification and colleges are advised not to make delay in sending applications along with the required documents or not to request for acceptance of late applications. The heads of institutions are required to ensure that applicant students to fresh batch who fulfill attendance requirement of at least 70% only are to be issued admission tickets for the examination.
7. The application with penalty of Rs.1500/- must reach on the Date/Day mentioned in this Notification or else it will be rejected.
8. You are requested to send the Fresher`s and Repeaters applications in a separate covers along with the covering letter.

## **MANDATORY INSTRUCTIONS**

1. It is mandatory for colleges to fill the Percentage of Attendance and you must also ensure about the eligibility of the candidate to write the examination in case of fresh student.
- 2.If Attendance is short and not mentioned in the Attendance list submitted by the college, the Application will be rejected once for all.
- 3.The Applications of such candidates should not be forwarded to University, who could not fulfill minimum 70% of ATTENDENCE and whose admissions are not approved by the Academic section of KSLU.
4. In case college forwards any type of ineligible applications, the principal will be solely responsible for future consequences.
